All eligible applications received will be screened with respect to the eligibility conditions and candidates fulfilling the eligibility conditions shall be called for Personal Interview. The merit will be done based on marks secured in qualifying examination [Degree/Diploma as applicable].

## **HEALTH STANDARDS**

Applicant should have sound health. ## GENERAL TERMS AND CONDITIONS

1. The posts are purely temporary in nature and offered on a Fixed Tenure basis for a period of initial Two Years or completion assignment whichever is earlier. This post is not against any permanent vacancy. This placement will not entitle the candidate for any regular/ permanent employment in BHEL in future and the engagement is only for the identified Project/ Assignment for the period stated.
2. Candidates should possess the required qualification and experience as on 12.01.2026, and produce relevant original Certificates/ Documents at the time of interview, if called for. In case it is detected at any stage of selection process that the Candidate does not meet the eligibility criteria and / or the Candidate has furnished any incorrect / false information or has suppressed any material fact(s), the candidature of such a candidate is liable to be rejected.
