1. IISER Berhampur ensures gender equality in its recruitment process. The Institute strives to have a workforce which reflects gender balance and women applicants are encouraged to apply.
2. The applicants are required to apply through **ONLINE** only. **NO NEED TO SEND HARD COPY.**
3. Please visit Institute website www.iiserbpr.ac.in for submission of online application through the online link.
4. In case of shortlisting for further selection test, the applicant has to produce the hard copies of all requisite document in original for verification at the time of selection test, as applicable.
5. While filling in the online application, the applicant has to upload legible self-attested copies of all relevant documents such as educational mark sheets/ certificates/ experience certificate/ caste certificate/ relieving order/ valid ID proof issued by State/Central Govt. and other supporting documents as claimed in the online application portal, as applicable.
6. The applicant is required to pay a non-refundable application fee of ₹500/- (Rupees Five Hundred only) through online for each post applied. However, the application fee is exempted for applicants belonging to Women/SC/ST/Ex-servicemen/PWD/Transgender category. For claiming such exemptions, the applicant has to submit a self-attested copy of latest SC/ ST/ PwD/Transgender certificate/Identity Proof/ Discharge Certificate, as applicable. Application fee once paid shall not be refunded under any circumstances.

8. Applicants are advised to fill in their **correct and active e-mail address** in the online application form as all correspondences will be made by the Institute through e-mail only. The recruitment schedule will be made available on Institute website only. A list of shortlisted and rejected applications will be published post-wise on Institute Website for information of all. No separate letter (Hard copy) will be sent for this purpose. Further, for any updates, subsequent amendments/corrigendum in the advertisement and results, please visit the Institute website (www.iiserbpr.ac.in) regularly.

9. The applicants applying for any post should ensure that they fulfill all the eligibility criteria and conditions for the post. Their admission to any stage of the selection process will be purely provisional subject to confirmation that they satisfy the prescribed eligibility conditions. Mere issue of call letter to the applicant for attending the selection test will not imply that his/her candidature has been found eligible.

10. Age relaxation will be provided to the specified categories as per Govt. of India norms as applicable from time to time.

11. Due relaxation in respect of age will be given to SC/ST/OBC applicants as per Government of India norms, only against reserved vacancies for such categories and can only be claimed on submission of valid community certificate issued prior to the date of issuance of this recruitment notice. In other words, no age relaxation would be available for SC/ST/OBC applicants applying for unreserved post/vacancies.

12. For Institute's regular employees, there will be no upper age limit. However, at least a year of service has to remain on the last date of submission of application till superannuation of the internal candidate.

13. Eligibility of applicant with regard to qualification, age & experience shall be reckoned/considered as on last date of submission of online application. Degree as referred above should have been awarded by a recognized University / Institute.


14. The period of deputation shall be for three years from the date of commencement of the deputation, as per DoPT guidelines as amended from time to time. The terms and conditions of appointment on deputation will be governed by the guidelines vide DoPT letter no. 6/8/2009-Estt. (Pay II) dated June 17, 2010 and as amended from time to time.

15. The Institute reserves the right to:

- Conduct written and/or trade test as applicable under the rule for the post wherever the circumstances so warranted or may fix a criterion after taking into the qualification and experience of the applicants.
- Fill up consequential vacancies including additional post arising at the time of selection test for available applicants by direct recruitment. The number of positions is thus open to change.

16. The Institute has a right to decide the mode of screening and testing the applicant for shortlisting and selection.

17. The Institute also reserves the right to fill the posts fully or partially depending on the availability of suitable applicants without assigning any reasons thereof.



18. Mere eligibility does not vest any right on any applicant for being called for selection test. The Institute may fix suitable shortlisting criteria which may be more than the prescribed essential qualification and experience in the event of receipt of large number of applications. The decision of the Institute in all matters related to recruitment against this advertisement shall be final. No correspondence will be entertained from the applicants in connection with the process of selection test. **Canvassing in any manner would entail disqualification of the candidature.**
19. The Institute shall verify the antecedents or documents submitted by applicants at the time of appointment or during the tenure of the service. In case, it is detected that the documents submitted by the applicant are fake or the applicant has a clandestine antecedents/background and has suppressed the said information, then his/her service/engagement at the Institute shall be terminated.
20. **Probation period for all regular positions is 01 (one) year.**
21. Persons employed in Government/Semi-Government Organizations/Autonomous Bodies/PSU should upload NOC cum Vigilance cum Experience Certificate as per the prescribed format only mentioned in the advertisement while submitting the application through online.
22. Applicants applying for more than one post should apply in separate application forms. Separate application fees will also be required to be paid (as applicable).
