The necessary instructions for filling up of online applications in this regard are as under:

- 1) Candidates are required to apply through online mode only, by accessing the website of JKSSB www.jkssb.nic.in. No other means/mode of application will be accepted.
- 2) All the candidates shall be required to register on the Portal by clicking on '**Log-in (Apply on Various Posts)**' tab available on the Board/JKSSB website.
- 3) Candidates are required to have a valid e-mail ID and Mobile Number for registering by clicking on "**New User / Sign Up**" and creating login credentials. The same shall be validated using OTP (One Time Password) based verification on e-mail and if the verification code is not working, the candidates are required to resend the verification code for account activation by clicking on "**Get Activation Code**".

- 4) Candidates are advised to use their username only generated while registration of their application form or received with the account activation mail instead of their e-mail ID.
- 5) After registering/creating login credentials, the candidates shall complete their OTR (One-Time Registration) form. After the completion of OTR form, the candidates shall click on '**Active Advertisement**' tab and then click on '**Apply**' tab for submitting the application form for the advertised posts.
- 6) **The candidates shall carefully fill in all correct information in various columns and click on 'SAVE & CONTINUE'.**

- 8) A clear **Signature of the candidate** shall be uploaded with following specifications:

- 9) A valid (within cut-off date) and genuine **Category Certificate** shall be uploaded with the following specifications: *(Max size- 100 KB in pdf format).*
- 10) Valid (within cut-off date) and requisite **Qualification Certificate(s)** shall be uploaded with the following specifications: *(Max size- 100 KB in pdf format).*
- 11) **The candidate shall ensure that all the required fields are filled up with correct information, before final submission of the application form. Once submitted, the Application Form cannot be edited by the candidates. They shall be personally responsible for filling the details in the Online application form and the information/details furnished by the candidates shall be treated as final for the purpose of determining the eligibility/claims of the candidates. No claim on account of wrong/non-filling of information shall be entertained subsequently. Benefits related to category, weightage etc. shall be claimed only in case of possession of a valid, within the cut-off date certificate to this effect and no such claim shall be entertained at any subsequent stage.**
- 12) Candidate's Application will not be considered if fee is not paid for that application. Fees shall be paid only by **Net banking/Debit Card/UPI/Credit Card Options:**

01.) APPOINTMENT OF THE CANDIDATES:

The Appointment and other service conditions in respect of the candidates selected through this selection process shall be governed as per extant rules/regulations of the Government of UT of J&K.

02.) DOMICILE:

The candidate(s) seeking to apply for the advertised posts shall be Domicile(s) of the Union Territory of Jammu & Kashmir and must possess a **valid Domicile Certificate issued by the Competent Authority on the prescribed format on or before the cut-off date i.e. last date of submission of online application forms**, which, unless otherwise extended, shall be **13.01.2026**.

03.) VACANCIES:

The details of posts advertised are given in **Annexure-A** to this Notification. **However, the actual number of posts may undergo increase or decrease during or before the completion of the selection process and the JKSSB is not legally liable for any such variation in the total number of posts advertised for which the final selection list will be issued. 05.) QUALIFICATION REQUIRED:

- a)** As per the Indent and clarification(s) received from the Indenting Department, the Qualification prescribed for the advertised posts is shown in **Annexure-A** to this Notification.
- b)** The candidates who are declared qualified/shortlisted by the Board for Document Verification will be required to produce relevant Certificates in original as proof of having acquired the prescribed educational qualification strictly **on or before the cut-off date fixed for filling online application forms, failing which the candidature of such candidates shall be cancelled by the Board.**
- c)** **Candidates may note that their candidature/admission in examination will remain provisional till the genuineness and validity of their documents relating to educational/Technical qualification is verified by the Appointing Authority.**
- d)** In case of candidates claiming possession of equivalent educational qualification (where it is applicable/required), it shall be mandatory to produce relevant Equivalence Certificate or seek equivalence from the concerned competent authorities as and when required by the Board. *However, final decision regarding selection of such candidates will be taken by the Board, in light of relevant rules which shall be binding.*
- e)** Any candidate having his/her qualification other than as prescribed, shall not be eligible for posts advertised in this notification and such candidature will be summarily rejected.

06.) APPLICATION OF RESERVATION:

- a)** The Reservation for the posts under this Advertisement Notification shall be applicable as per the Category-wise break up of vacancies as conveyed by the Indenting Department and/or in accordance with the provisions of the Jammu & Kashmir Reservation Act/Rules, as amended from time to time.
- b)** **A candidate seeking consideration under Reserved Categories must ensure that they possess a valid/ Category Certificate strictly as on the Cut Off Date and the same is required to be uploaded while submitting online application. It may be noted that no further opportunity to upload any document shall be provided hereafter and action under rules including rejection of application/candidature may be taken strictly as per the legal validity of the uploaded document w.r.t. the prescribed cut-off date.**

- c) Candidates may note that their candidature will remain provisional till the genuineness and validity of the Reserved Category Certificate is verified by the Appointing Authority.
- d) Candidates are cautioned to note that in case a claim for reservation is made on the basis of Invalid/false/fake/fraudulent/forged certificate, they shall be debarred from the examination(s) conducted by the Board, besides penal action as may be deemed appropriate should be initiated against them.

07.) HORIZONTAL RESERVATION (wherever applicable under rules):

- a) Horizontal Reservation means the reservation which would cut across the vertical reservation and the persons selected shall have to be placed in the appropriate category by making necessary adjustments.
- b) **Horizontal Reservation for Ex-Servicemen (ESM) candidates and Women candidates** shall be applicable to the extent as communicated by the Indenting Department(s) in accordance with the extant rules/regulations.
- c) **The Persons with Benchmark Disabilities (PwBD) are not eligible for these posts.**
- d) Horizontal Reservation for Ex-Servicemen candidates is applicable as per extant rules, for the posts which carry Pay of and up to the Level-6E (35900-113500).
- e) In terms of S.O. 361 of 2021 dated 20.10.2021, an Ex-Servicemen on joining any post after having availed Horizontal Reservation, cannot avail the benefit of Horizontal Reservation as Ex-Servicemen for any subsequent Employment. *A candidate seeking to apply under ESM category shall be required to submit an affidavit duly sworn before 1st Class Judicial Magistrate in this regard at the time of scrutiny of the documents.*
- f) ESM candidates shall be required to produce a Certificate in form-XIV duly signed by the competent authority as provided in the Rule 18 of Jammu and Kashmir Reservation Rules, 2005.
- g) In case sufficient number of candidates belonging to the Ex- Servicemen are not available on the basis of General standard to fill all the vacancies reserved for them, candidates belonging to the category of Ex- Servicemen may be selected under the relaxed standard of selection to make up the deficiency in the reserved quota subject to the condition that such relaxation will not affect the level of performance by such candidates.
- h) **In terms of S.O. 288 dated 14.06.2022, of Home Department, Horizontal Reservation to the extent of 15% of the available vacancies in direct recruitment shall be earmarked for women candidates in non-gazetted ranks.** The quota so reserved shall not be carried forward to the subsequent year, in case suitable women candidates are not available.

08.) APPLICATION FEE:

- a) **Fee payable: Rs.700/-(Rupees Seven Hundred only).In case of candidates belonging to SC, ST-1,ST-2 and EWS category, the fee payable shall be Rs.600/-(Rupees Six Hundred only).**

- b)** Fee can be paid only through online mode viz. Net Banking, Credit or Debit cards.
- c)** Applications received without the prescribed fee shall not be considered and summarily rejected. No representation against such rejection will be entertained. Fee once paid shall not be refunded under any circumstances nor will it be adjusted against any other examination or selection.
- d)** All the disputes related to refund of excess payment, if any, are subject matter of relevant bank and J&K Services Selection Board. Candidates are advised to apply for refund of excess payment, if any, through official e-mail ***ssbjk-grievance.jk.gov.in*** only. **No chargeback request shall be entertained.**

09.) DATE & CENTRE OF EXAMINATION:

The J&K Services Selection Board shall notify the date for examination and the Venue/Centre(s) of examination separately. The details shall be made available on the website of the Board i.e. **www.jkssb.nic.in**. No representation/request for change in this regard shall be entertained, whatsoever be the reason.

10.) SCHEME OF EXAMINATION:

(I) WRITTEN EXAMINATION:

- a)** The Examination will consist of Objective Type Multiple Choice Questions. The questions will be set in English Language only.
- b)** There will be Negative Marking for each wrong answer to the extent of one-fourth of marks assigned to that question.
- c)** In terms of **SO 290 dated 20.08.2021** of Home Department, the candidates **possessing National Cadet Corps (NCC) Certificate** shall be awarded bonus marks, at the following scales:
 - i) 5% of the maximum marks of the examination for NCC "C" Certificate holders.
 - ii) 3% of the maximum marks of the examination for NCC "B" Certificate holders.
 - iii) 2% of the maximum marks of the examination for NCC "A" Certificate holders.

(II) PHYSICAL STANDARD TEST: The candidates shall be shortlisted for appearing in the physical standard test on the basis of written test which shall be six times the total number of vacancies to be filled up in each category. The shortlisted candidates should meet the following physical standards:

a) For Males:

- i) Height: 5'-6" (minimum)
- ii) Chest girth: 32" (unexpanded)
- iii) Chest girth: 33 1/2" (expanded)

b) For Females: Height: 5'-2" (minimum)

- (i) Provided that for the candidates belonging to the Gorkha Community, the minimum Height shall be relaxable by 2".

(ii) Provided that for the candidates belonging to the Bot Tribe, the minimum Height shall be relaxable by 2". (**S.O. 343 dated 21.06.2024 of Home Department**).

(III) PHYSICAL ENDURANCE TEST: The candidates who meet the above physical standards shall be required to undergo physical endurance test, which shall consist of the following:

A) I) For Male candidates

Long Race: 1600 meters in 6 1/2 minutes (Six minutes thirty seconds)

Pushups: 20 (one cycle of up and down to be counted as one)

II) For Female candidates

Long Race: 1000 meters in 6 1/2 minutes (Six minutes and thirty seconds)

Shot put(4Kgs): 14 1/2 feet in three attempts.

B) Special provisions regarding relaxation in Physical Endurance Test for Ex-Serviceman:

The Ex- Serviceman candidates shall be required to qualify Physical Endurance Test as per the following relaxed standards:
