- In case large numbers of applications are received, short listing of candidates for interview will be done based on their qualification, additional qualification, experience etc., or through a written test.

- Only those candidates who have been declared successful in their qualifying degree exam and will be completing their tenure for the same on or before the closing date of application will be eligible.
- In cases where result of qualifying exam is declared after the closing date of application, their candidature will stand cancelled and no claim for selection on the basis of interview will be considered.

15. **Caste/Category Certificates:**

**(A) OBC Category**

- i. The vacancies are being advertised in financial year **2026-2027**, therefore, valid NCL-OBC certificate issued during the period **from 01.04.2026 to 31.03.2027** will be considered valid. Candidature who have OBC-NCL certificate issued before or after this period (i.e **01.04.2026 to 31.03.2027**) will not be considered valid for this advertisement.

**(B) EWS Category**

- ii. Application under **EWS category will be considered subject to submission of Income and Assets certificate on a prescribed format issued by the competent authority** and subject to verification of genuineness of the certificate by the issuing authority. As per DoP&T OM No. 36039/1/2019- Estt (Res), dated 31.01.2019, the crucial date for submitting income and asset certificate by the candidate is the closing date for receipt of application for the post, except in cases where date is fixed otherwise.

16. **For eligibility to applying for these posts upper age limit as on closing date will be 45 years.**
17. Age limit refers to completed age as mentioned in eligibility criteria, in years as on closing date.
18. The upper age limit for candidates with DM/M.Ch degree applying for these posts will be 45 years. The age limit is further relaxable for SC/ST candidates, OBC candidates & OPH candidates as below.
19. Age relaxation of 5 years for SC/ST, 3 years for OBC candidates. No age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.
20. In the case of Persons with Disability (PWD) candidates, age relaxation up to maximum period of 5 years for General Category, 8 years for OBC category and 10 years for SC/ST category candidates.
21. **For Persons with Disability (PWD):  
4% of the total posts will be horizontally reserved for Pwd Candidates with bench mark disability as per Reservation Rules. The RPWD Act/DoPT instructions as applicable in this regard will be strictly followed.**

### **TERMS & CONDITIONS**

1. Vacancies arising out of non-filling/resignation may be filled in a subsequent notified date through rolling advertisement.
2. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of Interview.
3. Canvassing of any kind will lead to disqualification. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
4. The appointment shall be as per Govt. of India's Residency Scheme. The appointment can be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority. The appointee shall be on the whole time appointment of the AIIMS and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract. He/She is expected to conform to the rules of conduct and discipline as applicable to the institute employees. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
5. The total residency period is of 3-year duration. If the candidate has worked as a senior resident in any Govt. medical institution, whether on regular or ad-hoc / Contract basis, the duration of Senior Residency already done will be reduced from the 3 years tenure to be offered.
6. Applicants should not have completed 3 years Senior Residency under Residency Scheme in any Govt. medical institution, whether on regular or on ad-hoc / Contract basis. The duration of Senior Residency already done will be reduced from the 3 years tenure to be offered.
7. If an appointee wishes to apply somewhere else or resign within the first 03 (three) months of joining, then neither he/she will be issued a No Objection Certificate (NOC) nor he/she will receive any Relieving Letter or Experience Certificate.
8. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
9. The candidate should not have been convicted by any Court of Law.
10. In case of any information given or declaration by the candidate is found to be false or if the candidate has will-fully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and any action taken as deemed fit by the appointing authority.
