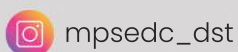

Introduction

Madhya Pradesh State Electronics Development Corporation Ltd. is intended to introduce Graduate Engineer Trainee Program 3.0 to onboard freshers (as defined in the eligibility section) through a competitive selection method and provide them training program at MPSeDC for a period of 1 year. The examination shall be conducted by MP Online Ltd.

Applicants who have successfully completed Graduation or Post-Graduation as per defined eligibility criteria or are in their Final Semester or preparing for their final exams, can appear in the examination to be held online. Based on their performance in the examination, merit list will be prepared and the candidates in merit list will be provided with an opportunity to join the Graduate Engineer Trainee Program 3.0 at MPSeDC. Selection of candidates is strictly subject to their qualifying the online examination. There are no other means by which candidates would be onboarded for training.

The selected candidates would join as trainee and would receive a stipend every month. Their performance would first be reviewed internally at the end of 6 months and again at the end of 12 months. Only those who score above a certain threshold will be retained and the rest would be disassociated after being issued a certificate certifying their association with MPSeDC for the said duration. However, certificate of training shall be awarded only to those candidates who complete at least 3 months of training at MPSeDC.

Objective of the Scheme

The objective of the scheme is to align with the vision of "Digital India" and "Viksit Bharat" by empowering the youth of the state through next-generation tech skills. MPSeDC has launched this initiative to cultivate future-ready talent and transform fresh graduates into highly employable professionals. Through specialized, hands-on training in IT and e-Governance, the program bridges the industry-academia gap to build self-reliant individuals capable of driving India's digital transformation.

Eligibility

S. No	Eligibility	Criteria
1	Educational Qualification	i. Candidate who are in their final semester or have completed their Graduation / Post – Graduation in Engineering (any discipline) ii. Candidates who are in their final semester or have completed their Graduation / PostGraduation in Computer Science / IT or equivalent domain. iii. However, in respect of i & ii above, the award of a degree to the candidate and the notification of advertisement for the Graduate Engineer Trainee Program by MPSeDC should not be separated by more than a year (365 days). iv. Diploma or PG Diploma holders shall not be considered for this Graduate Engineer Trainee Program. v. Candidates awaiting final semester results may apply subject to submission of marksheet / provisional degree / degree within 2 months of joining.
2	Age	Not less than 18 years and not exceeding 30 years of age at the time of notification of advertisement.
3	Nationality	Applicable to 'Indian Nationals' only
4	College/ Institute	Recognized/ Accredited with AICTE/ UGC
5	Domicile	Both types of Candidates are eligible i.e Non Domicile and Domicile candidates, however, they should have completed their qualifying degree from Madhya Pradesh

Examination Details

1	Mode of Examination	Online
2	Duration of Exam	Three Hours (180 minutes)
3	Question Paper	Question Paper will consist of a mix of Multiple-Choice -Questions & Programming Questions. There shall be 85 MCQs & 15 Programming Questions
4	Examination Centers	It is up to the discretion of the MP Online. The proposed center are Bhopal, Jabalpur, Indore, Gwalior, Sagar, Ujjain & Satna (4 Preferences will be taken and duplicate choices will not be acceptable)
5	Minimum passing marks	- The minimum qualifying percentage in the exam shall be 35% - Candidates scoring less than 35% shall be rejected.
6	Verification of Documents	- After qualifying the online exam & before joining the Graduate Engineer Trainee Program, the selected candidates will undergo document verification at MPSeDC. Complete documents of the candidates including identity proof, marksheets, degree etc. are verified. - Candidates whose documents are found complete and in order, are issued joining letter by MPSeDC
7	Date of Joining	- Candidates who have already completed their Graduation/ Post-Graduation and who are on the merit list and received the Joining letter from MPSeDC are expected to join the training program within 15 days from the date of issuing of the Joining letter. - In case of no show within 15 days of the joining date mentioned in the letter, their candidature will be nullified without any intimation to the candidate and the candidate in the wait list will be given an opportunity. - Candidates who are in their Final Semester or are preparing for their Final exams and have qualified the exam conducted for the training program can follow the process below: - Candidates who are in the merit list and received the Joining letter from MPSeDC are expected to join the training program within 15 days from the date of completion of final exams. - In case any candidate is unable to clear his/her exam, his/her candidature for the training shall be cancelled.
8	Validity of Merit List	The merit list will be valid till the next notification for the examination or 6 months, whichever is earlier.
9	Selection & Waitlist	- Opportunity for training shall be provided to top 150 candidates as per merit list and the remaining qualified candidates shall be kept in the Waitlist. Waitlist of upto 50 candidates shall be prepared. - Candidates shall be given opportunity in sequential order of merit - In case of a NO SHOW from 15 days of the joining date, the candidature will be nullified without any notification to the candidate, and the candidate in the wait list will be given an opportunity. - Waitlist will be valid till the next notification for the examination or 6 months, whichever is earlier. - Waitlist does not make the candidate eligible for selection. For each exam, Waitlist criteria shall be seen in an independent manner.

MPSEDC Graduate Engineer Trainee Program 3.0 Condition

Stipend

During the period of training, the trainees shall be paid a stipend of Rs.25,000/- per month. Those who quit training in between, shall be paid stipend on pro-rata basis.

Assessment

Graduate Engineer Trainees who clear the Half Yearly & Yearly Assessment, will be issued "Certificate of Completion" and will be given an opportunity to appear in the interviews for the position of Associate Engineer at MPSEDC on the payroll of our empanelled Third-Party Agencies

Working Hours

As per the working hours decided by MPSeDC.

Leaves

During the training period, the trainees shall be allowed to take only 1 Casual Leave per month. There is no provision of leave encashment. However, in exceptional situations, Leave Without Pay (LWP) of maximum 3 days in a month may be granted at the discretion of Officer In-charge under whom training is being offered to the candidate.

Laptop

During the period of training, the trainees are expected to use their own laptop.

Travel

Candidates will not be eligible for any Travel Allowance/Dearness Allowance for appearing in the examination. However, those selected as trainees, would be reimbursed in accordance with the HR Policy of MPSeDC and equivalent to CoE Developers role, if they are required to travel to some other office or city for project related work, during their course of training.

Insurance & Medical

No Insurance & medical related benefits will be provided to trainee.

Separation/ Disassociation

1. GETs may voluntarily exit the training anytime during the course of the program. However, prior to exit, they shall have to give notice period of 1 month.
2. Candidates failing to secure minimum qualifying marks in their half-yearly / annual assessment shall be disassociated from the program.
3. Upon completion/disassociation, all official materials shall be returned to MPSEDC.

Eligibility for Certificate

Those candidates who leave the training program before completing 6 months, will not be entitled to receive any certificate of training.

NDA with the Candidate

Candidate has to sign Non-Disclosure Agreement with MPSeDC before joining the training program.

Exclusivity

All disputes related to the policy shall be subject to the exclusive jurisdiction of Courts of Bhopal.

It is mandatory for the applicant to take care of the following points-

- Candidates shall have to apply through MP Online Portal (www.mponline.gov.in) only.
- It is mandatory for the candidate to apply online only. No applications will be accepted through hard copy. If no information is given or incomplete information is given, the application will be rejected as incomplete.
- Clear scanned and self-attested copies of the documents of the candidate to be uploaded for online application along with a latest passport sized photograph which should not be older than 6 months from the date of issue of advertisement or after the date of issue of advertisement.
- High school certificate will be accepted for proof of age. Other certificates will not be accepted.
- Certificate or mark sheet of Graduation/Post-Graduation degree from recognized university has to be uploaded. Relaxation can be given to those candidates who are pursuing education and are in their final semester. But it will be mandatory for them to submit their Provisional Degree/Marksheet to MPSEDC at the time of verification and joining. In the event of the candidate not being able to pass the Graduation/Post-Graduation examination or not being able to submit the provisional degree/marksheet within the stipulated time, his/her candidature will be canceled and the candidate from the waiting list will be given the opportunity.
- Before joining the training, it will be mandatory for the selected candidates to present self-attested copies of related essential educational qualifications, mark sheets, technical educational certificate (if any) of the entire year, after which the eligibility of the candidate will be checked.
- Before submitting the application, candidates are expected to go through all the points carefully and apply only if they meet all the essential eligibility criteria. In case any information furnished by the candidate is found to be wrong or incomplete at any stage during or after the application process, the application and hence his candidature for internship shall be cancelled without giving any information or notice.
- Such candidate shall be liable for criminal prosecution:
 - who has submitted false documents or documents which have been tampered with, or
 - has impersonated or made to impersonate any person, or
 - has furnished false information or suppressed material information or used or attempted to use unfair means at any stage of the selection process.
- MPSEDC reserves the right to cancel or discontinue the training program at any point of time without assigning any reason.
