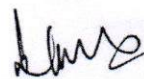

2. The eligible and willing candidates should be sponsored by concerned Employment Exchange.
3. The candidate should be a citizen of India and permanent resident of the State of Manipur. The candidate should speak Manipuri or any of the notified Schedule Tribe dialects of Manipur.
4. The appointment shall be purely on contract basis for the period from the date of contract agreement up to the closing of the financial year and extendable from time to time.
5. Essential Educational qualifications and Age limit of different categories of posts and remuneration shall be as per the appended table in Annexure. **There shall be one time age relaxation of 2(two) years to applicants above the upper age limit.**



6. Candidates willing to avail the Meritorious Sports Quota should furnish duly filled in Forms/Formats appended to the Office Memorandum No.9/1/83-DP dated 17/10/1998 issued by the Department of Personnel, Government of Manipur relating to the Appointment of Sportspersons to Class III & IV posts in relaxation of the Employment Exchange Procedure whichever is relevant. 7. The mode of selection for engagement of eligible candidates shall be on the basis of written test + viva voce for the post of **Asst. Agriculture Officer/Equivalent (Group B)**. The written test for the post of Asst. Agriculture Officer/Equivalent shall consist of a Multiple Choice Combined written test (MCQ) comprising of General Knowledge (25 Marks), General English (25 Marks) and General Agriculture/Horticulture (50 Marks).

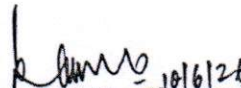

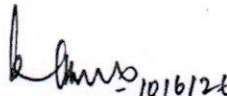

## **INSTRUCTION TO THE CANDIDATES FOR FILLING UP THE APPLICATION FORMS**

- 1) Candidates intending to apply for more than one post should apply with different application form for each post concerned separately.

- 3) In case of Caste certificates, the certificate should be valid as on the date of submission of the application form.
- 4) Application fee shall be
  - i. For the Post of **Assistant Agriculture Officer/Equivalent**, Rs 1000/- (One thousand) only for General & OBC Categories, Rs 800/- (Eight hundred) only for SC &ST categories and PwD is Nil.
  - ii. For the Post of **Field Assistant/Equivalent and LDC/OACCO**, Rs 800/- (Eight hundred) only for General & OBC Categories, Rs 500/- (Five hundred) only for SC &ST categories and PwD is Nil.
  - iii. For the Post of **Group D**, Rs 500/- (Five hundred) only for General & OBC Categories, Rs 300/- (Three hundred) only for SC &ST categories and PwD is Nil.
- 5) Only cash will be accepted on counter at the time of submission of application form.
