1. How to apply:

- Fill in all the details in the application form, including the Enrolment Number generated after successful registration in the NAPS/NATS portal. (For registration, please refer the instruction in point no. (2) of this notification.
- Bring the duly filled-in application form along with all original and one set of photocopies of all relevant testimonials with self-attestation on the date of interview

2. Apprenticeship Registration:

3. Date, Time & Venue of Walk-in-Interview:

The Walk-in-Interview will be held on **10th August 2026 (Monday) at 09:00 AM** (Reporting Time: 08:45 AM) at **CSIR-Central Electrochemical Research Institute (CSIR-CECRI), Karaikudi**. No candidate will be permitted to enter the interview venue after 10:30 AM.

4. Eligibility conditions & requirements:

i) **Age Criteria:** As on date of interview i.e.) on 10.08.2026

Relaxation: Age relaxation is applicable as per the Govt rule for reserved categories

Ex-Servicemen: Upper age limit is relaxed up to additional 10 years to the extent of service rendered in Defence Forces

ii) **Trade (ITI) Apprentices:**

Candidates who have passed in the particular trade (except Glass Former and Processor) of NCVT pattern designated by Director General of Employment & Training (D.G.E.&T) and should be registered as Trade Apprentices in the NAPS portal before the date of walk-in interview.

iii) **Graduate (Degree) / Technician (Diploma) Apprentices:**

- Full time graduate degree granted by a recognized university / Institutions in relevant discipline.
- Diploma in Engineering / Technology in full time granted by a State Council or Board of Technical Education established by a State Government/University/Institutions in relevant discipline.
- Graduate/ Technician who have passed the qualifying examination during the years **2022, 2023, 2024, 2025, or 2026** are eligible to apply for Apprenticeship training.

iv) **Not Eligible conditions:**

- Any Post Graduation (Even Integrated PG course)
- Passed in Non approved Institutions by AICTE/DOTE/UGC.
- Candidates should NOT have undergone any apprenticeship training earlier or pursuing Apprenticeship Training in the same qualification as per the Apprenticeship Act, 1961 as amended from time to time.
- Candidates should NOT have one year or more of work experience in any organization after acquiring the essential qualification.
- Sandwich diplomas, private diploma, part time/ Distance/ short term/ certificate courses etc., are not acceptable.

5. **Reservation of Vacancies:**

Guidelines under Apprentices Act on Reservation for SC/ST/OBC/PWD/EWS will be followed. Those who are claiming reservation under SC/ST/OBC/PWD/EWS shall provide certificate as per Government of India format, failing which their claim for reservation will be considered as 'General' category only.

6. **Other conditions:**

a) Interested and eligible candidates may appear for the Walk-in-Interview with the duly filled-in application form, along with all original certificates, one set of self-attested photocopies of the following documents, and one recent passport-size photograph on the date of the interview:

- All Certificates/Testimonials in respect of Qualifications, DOB, etc.
- Caste Certificate [for SC/ST/OBC (Non-Creamy Layer)/EWS candidates, as applicable] in the prescribed format issued by the Competent Authority as prescribed by the Government of India.

The original documents including educational qualification, Birth/SSLC certificate, community and experience certificate, etc., in respect of selected candidate will be verified at the time of walk-in-interview and in the event of failure to submit any of the required documents as mentioned above at the time of walk-in-interview, their candidature will not be considered.

b) In case the date of declaration of result is not mentioned in the Mark sheet, the candidate must submit a certificate mentioning the date of publication of result issued by the Principal of the Polytechnic / College / Institute from where the candidate pursued his/her Diploma / Degree course, along with application form.

c) If number of candidates is more, the Selection Committee shall adopt its own criteria and shortlist the candidates for walk-in- interview in proportionate to the available vacancies.

d) Selected Candidate will be provided accommodation in the Institute campus (if available) and license fee will be levied.

e) Successful apprenticeship trainees will be awarded National Apprenticeship Certificate by National Council for Vocational Training (NCVT)/ Board of Apprenticeship Training (BOAT).

f) If any corrigendum/addendum etc. or updates with regard to this advertisement shall be made available on our website: <https://cecri.res.in/> only.

g) Candidates are advised to periodically visit our website as all future correspondence and latest information with regard to screening/selection result shall be posted in our website (<https://cecri.res.in>) and/or by Email/SMS-alerts.

h) The applicant's candidature would be provisional and subject to subsequent verification of certificates and testimonials. In case, it is detected at any stage of engagement or thereafter, that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect, doctored, false information/certificate/documents or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of these shortcomings is/are detected even after engagement if any, his/her engagement is liable to be terminated.

Filling up of the seats is solely at the discretion of the Director, CSIR-CECRI, Karaikudi based on suitability of candidates and no claim will arise for engagement, if some of these seats are not filled due to unsuitability/ insufficient number of candidates.

j) Upon completion of the Apprenticeship period, CSIR-CECRI shall have no obligation to give regular employment to Apprentices. The Apprentices shall have no right to claim regular employment from CSIR-CECRI / CSIR or any of its Institutes /Laboratories on the grounds of completion of Apprenticeship.

k) Canvassing in any form and /or bringing in any influence, political or otherwise shall be treated as disqualification.
