2. Those who have completed the essential qualification i.e. Degree/Diploma in the relevant stream during the year 2024, 2025 and 2026 are only eligible to apply.
3. Any candidates who has not done apprenticeship earlier or has completed only one apprenticeship in a different trade at least one year prior to the date of publication of this advertisement shall only be eligible to apply.
4. This is purely an apprenticeship training program and the candidates will not be provided any regular employment after completion of the training. However, subject to availability of resources and ability to accommodate in different departments, candidates may be placed for Advanced Training /Trainee Project Executive in shipbuilding activities at the discretion of the Management in line with the advanced Training Scheme and Project Executive scheme of the Company.
5. Mode of selection is Written Test followed by Interview for induction of Graduate Apprentices. For Technician Apprentice the induction will comprise of Written Test and Practical Test. Only those candidates who are declared successful in the Written Test will be called for Interview / Practical Test, as the case may be.
6. Reservation for SC/ST/OBC/PWD will be as per Government of India rules.
7. Shortlisted candidates called for the test / interview will not be provided any TA/DA for appearing in the test as this advertisement pertains to engagement as apprentice only and not as an employee.
