Note:- In case the 2nd Tuesday and Last Tuesday of every month at 10:30AM and falls on a Holiday the interview scheduled for the next working day.

VACANCIES:-

Walk-in Interview for the post of SR on adhoc basis for initially 44 days in this Institute.

Interested candidates are hereby advised to check the availability of vacant post of their specialization before applying for the same.

The time for candidates appearing for walk-in-interview as per schedule and the application to be submitted in E-I Branch as per the interview schedules.

- The notice for a walk in interview in respect of the Mch Neurosurgery/DNB/MS(General Surgery) department of LNH for the post of Senior Resident in the Department of Neurosurgery may be allowed.

ELIGIBILITY:-

- Essential Qualification:-** MBBS with Post Graduate Degree/DNB/Diploma or Post Doctoral Degree (or equivalent, in the concerned specialty in from an NMC/MCI recognized university/institute and preferably possess DMC registration for the concerned specialty/super specialty. The tenure of the PG Degree/DNB/Diploma or post Doctoral Degree or equivalent should be completed as well as the result also should be declared before the date of interview.
- In case the applicants do not possess the aforesaid educational qualification, such candidates shall be treated as Non-PG SR and may be appointed for 44 days or till these posts are filled with suitable candidates with PG qualification whichever is earlier.
- Age Limit:** The age of Senior Resident should not be more than 45 years as on 01.07.2026.

2. **Relaxation of Criteria:** In accordance with circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi, the following relaxation shall be applicable in case of **non -availability of fresh candidates :-**

- In the specialties where there is perpetual shortage in specialties where no fresh candidates are available, candidates who have completed 03 years Senior Residency but are willing to serve as Senior Residents will also be allowed to appear in the interview.
- Separate merit lists for fresh candidates and for others (those who have completed 03 years of residency) will be prepared.
- In the first place, the list containing names of fresh candidates will be exhausted for appointment as Senior Residents and the second list will be taken up only thereafter.
- All appointments for Senior Residents from second list will be for a maximum period one year only. **It is not renewable further after expiry of one year.**

3. **EMOLUMENTS:** As per 7th CPC, Pay Matrix level 11(Rs. 67,700 - 208700) and other admissible allowances per month.

4. **TENURE:-** The tenure of Senior Residents will be for a period of 44 days (maximum 3 years including any service rendered as Senior Residents earlier on ad-hoc/regular basis in any NMC recognized teaching/non teaching institution.) or till regular Senior Resident join whichever is earlier, in accordance with the **Residency Scheme of GOI dated 05th June 1992 and subsequent extended Residency Scheme notified vide Circular No. F. No. 121/26/2010/H&FW/DSHFW/1996-2045 dated 10th June 2011.**

5. No NOC of any kind will be issued to the SR before the candidate has put in at least 44 days of continuous service.

6. No permission/leave will be granted to attend conference/seminars/workshops/fellowship programme of more than three days duration at any given date during the tenure of residency in the hospital. There is no fee for appearing in the interview.

7. Interested and eligible candidates may apply in the prescribed application format along with original & self attested photocopies of the requisite documents (i.e. MBBS Degree, Post Graduate Degree, DMC Certificate of DMC registration or acknowledgment for PG Degree, Cast Certificate and Proof of awards/Publications, if applicable & Identity proof viz. Aadhar card, Voter ID card, Driving license, Passport etc.) along with 2 (two) photographs should be submitted in E-I Branch.
8. No application will entertained beyond stipulated time. However, the candidate, only who have DMC (with PG Degree) or applied for registration with DMC (with PG Degree) and have enclosed acknowledge of DMC will be allowed to appear in the interview provisionally.
9. In case of number of applications are very high, the interview may be continued on the next working day. The same will be informed to the candidates verbally by Board Members on the date of Interview at the closing time. Therefore, candidates who are not interviewed on the said date shall not leave the place of interview, without the knowledge of Board Members. No separate communication will be made in this regard.
10. The candidates are advised to visit the following website of LNH regularly http://tte.delhigovt.nic.in/wps/wcm/connect/doit_lnpj/LNJP/Home/ for the result.
11. No separate information or call letter will be issued for the same.
12. Candidates must produce NOC from present employer.
13. No TA/DA will be paid to the candidates called for the interview.
14. Selected candidates shall be allowed to join within 10 days of issue of the offer letter failing which the offer shall stand automatically cancelled. No extension for joining will be considered.
15. Selected candidate will be allowed to join only provisionally if no DMC registration is available. Candidate will be taken on strength only after production of DMC certificate within one month from joining.
16. Mode of selection will be through interview only. No waiting list will be prepared in this interview only rank list will be prepared and same will be valid till next interview notice published.
17. In case of any inadvertent error detected at a later stage, the same will be rectified as per rules.
18. Competent Authority reserves the right of any amendment or cancellation of the interview.
19. Competent Authority reserves the right to decide in case of any dispute with regard to selection process.
20. The selected candidates can be posted anywhere in patient care/public interest in emergency.
