** For Apprentices engaged under NATS, 50% of the total stipend will be paid through Direct Beneficiary Transfer (DBT) by the Government.*

1. Important Instructions:

- Candidates must have acquired educational qualifications as prescribed above from a recognized institution and must have registered Apprenticeship portal (NAPS, NATS) with 100% profile completion.
- No equivalent qualification other than those mentioned above will be considered eligible.
- Only those who have passed their final exams in 2022,2023,2024,2025 & 2026 are eligible to apply.
- Candidates must possess a First Class in the qualifying examination of the relevant discipline with a minimum of 60% marks (55% for SC/ST/ PwBD).
- Candidates awaiting results or who have undergone job elsewhere for one year or more are not eligible.
- Minimum 18 years and maximum 26 years as on date of reckoning i.e. 01.10.2026. Relaxation will be given as per Presidential Directives on Reservation.

- **Additional Registration for DBT (Direct Beneficiary Transfer) under NATS:**
For Apprentices Under NATS Portal: Candidates must have an active Aadhaar-seeded bank account that is DBT-enabled for Direct Benefit Transfer as per Government of India norms. These details should be submitted in the during the time of application.

- Candidate have to apply in the link provided above.
- Once registered on the NATS / NAPS Apprenticeship Portal, as applicable, the candidates need to LOGIN to the respective NATS/NAPS portal using their User ID/Email ID
- Candidates have to apply for the Apprenticeship Openings / Opportunities with “Chennai Petroleum Corporation Limited” as the Establishment Name.
- Candidates have to complete/update the profile by uploading all the required documents.
- Applications must be submitted online through respective apprenticeship portal only.
No other mode of application will be entertained.

4. Shortlisting:

Shortlisting of candidates will be done based on the merit list formed on the basis of percentage of marks obtained in the essential qualification applicable to the respective trade.
